### Offense Narrative

On 06/10/2026 at approximately 1921 hrs, I was in Sikeston DPS Officer parking lot on south of the Sikeston Department of Public Safety Headquarters. This parking lot is where officers park their personal vehicles. I was beginning my shift and waiting for PSO Jackie Hays to respond to Headquarters with my assigned patrol vehicle.

PSO Hays arrived prior to 1921 hrs. I started loading the patrol vehicle with my duty bags. As I was taking my duty bags from my personal vehicle, a subject approached me from the west in the parking lot. I was familiar with this subject as being:

Lloyd Gilmore b/m  
DOB: 09/25/1981

I am familiar with Mr. Gilmore from numerous calls for service. The last time I came into contact with Mr. Gilmore was approximately one week ago at the apartments located on Lawrence in Sikeston, MO. Mr. Gilmore was transported by the New Madrid County Ambulance Service at that time due to his delirious state of behavior.

On this date, as Mr. Gilmore was approaching me on foot, I asked, "What Lloyd?" due to him saying something I could not understand. Mr. Gilmore walked up to me so close that his chest touched my chest. I then instructed him to "Stand Back" and as I told him this I placed my right hand on his chest and pushed him away to gain some distance between us. Mr. Gilmore then started to explain about the incident from the Lawrence Apartments that I referred to previously. He was explaining his daughter was "against him" and trying to "cause some type of confusion". He then asked for me to take him inside and he would explain. I then told him I was not taking him inside and that he had no criminal charges placed against him.

Mr. Gilmore appeared to be sweating profusely and he was not acting as the person I have known for the past twenty years. I told Mr. Gilmore to leave at which time he grabbed the back of my vehicle. His right hand grabbed the top of my trunk lid and I instructed him to get off my vehicle. He continued to lean on my vehicle and grabbed the trunk lid. He would not comply and at this time I approached him and placed my left hand on his right shoulder and grabbed his right wrist. PSO Hays was on the left side of Mr. Gilmore and tried to grab Mr. Gilmore's left arm.

Mr. Gilmore began twisting his body and pulling his arms away from us. He started yelling and violently twisting away from our grasp. PSO Hays deployed his taser and "drive stunned" Mr. Gilmore on the left side of his torso. As PSO Hays was "drive stunning" Mr. Gilmore, Mr. Gilmore bent over and bit my right hand. My right hand was on his right wrist and I was trying to pull his right hand behind his back; however, his arms and torso were wet with what appeared to be perspiration. This caused my hand to slip off his wrists numerous times. When I felt Mr. Gilmore bite my right hand, I then delivered a forearm to the right brachial area of his neck. This had no affect on Mr. Gilmore. I then struck him several times on the side of his face but this had no affect. Mr. Gilmore then dropped all of his weight to the ground and fell backwards away from on the ground. He spun around on the ground and PSO Hays attempted to Tase Mr. Gilmore with the probes. Mr. Gilmore got up and ran east through the parking lot, in between two buildings where he crossed South Kingshighway.

Other units were arriving and Mr. Gilmore ran into the parking lot of the old Myres Building located on the east side of South Kingshighway. I drove to the location as I was following other units who were pulling into the Myres parking lot. Once I pulled into the parking lot, Mr. Gilmore was on the ground being handcuffed by other units.

I informed Mr. Gilmore he was under arrest and he asked, "What did I do?". I informed him he bit me and I instructed him to stand up. We pulled Mr. Gilmore up to his feet and he dropped his weight causing us to have to hold his weight to prevent him from falling. He then leaned forward which due to the amount of perspiration on his arms and torso, Mr. Gilmore came out of our grasp and he fell to the ground and landed on his buttocks. It took three officers to pick Mr. Gilmore up and carry him to my patrol unit. Mr. Gilmore was placed into the patrol unit head first in a horizontal position. Once the officers got Mr. Gilmore to the patrol unit, Mr. Gilmore tried to bite PSO Rodriguez.

FTO Meredith was on Mr. Gilmore's left side and PSO Rodriguez was on Mr. Gilmore's right side. PSO Cohen had Mr. Gilmore's feet and the three of them placed Mr. Gilmore into the rear of my patrol unit. Once Mr. Gilmore was placed inside, Mr. Gilmore kicked both of his feet upwards and struck PSO Rodriguez in the face. I went to the other side (driver's side) of the vehicle to assist FTO Meredith who had the driver's rear door open. Mr. Gilmore's head was hanging out of the door and

it appeared he was trying to maneuver himself out of the vehicle. Hobble restraints were placed on Mr. Gilmore's feet to prevent him from kicking his feet toward our direction.

Lt. Wierschem instructed them to remove Mr. Gilmore from the vehicle as we were going to place him in the transport van as the van had more room. As FTO Meredith was slowly pulling Mr. Gilmore out of the vehicle, Mr. Gilmore lunged his head downward which caused him to come out of the patrol unit in what looked like a barrel roll. Mr. Gilmore landed on the ground on his back and he began kicking both his feet. Mr. Gilmore was trying to kick us as we were trying to restrain his legs to prevent injury to us and to Mr. Gilmore. I placed my knees on the backs of Mr. Gilmore's legs to prevent him from kicking his feet. Mr. Gilmore was laying partially on his right side as the hobble restraints were attached around his feet and to the handcuffs around his wrists. During the placement of the restraints, Mr. Gilmore twisted to his left side. Mr. Gilmore was then laying on his left side as the restraints were attached to the handcuffs.

Mr. Gilmore was carried to the transport van. As the officers were carrying Mr. Gilmore to the van, Mr. Gilmore was trying to kick his feet and moving his torso which made it difficult for the officers to carry him to the van. He was then placed into the van. PSO Terrell got into the van with Mr. Gilmore and a short time later, Mr. Gilmore spit in PSO Terrell's mouth. PSO Terrell removed himself from the van at this time. The door to the van was then shut and Mr. Gilmore was transported to Headquarters.

I then drove back to Headquarters where I docked my body camera into the docking station to download the video as it would be evidence. When I walked to the report room I noticed Mr. Gilmore was not in the booking room yet so I went to the booking room. PSO Terrell was in the booking room looking for a spit mask. I then went to the sally port where other officers were with Mr. Gilmore. I did not have my body camera at this time due to it downloading.

When I walked into the "Sally Port", Mr. Gilmore was still inside the transport van. PSO Rodriguez was speaking with Mr. Gilmore through the door trying to calm him down and negotiate with him so there would be no problems. I then heard Mr. Gilmore say "Fuck You" after PSO Rodriguez told him he was going to open the door. PSO Rodriguez opened the door and Mr. Gilmore lunged out of the van and fell to the floor. Once on the floor, Mr. Gilmore started "writhing" up and down and kicking his feet. He then started hitting his head on the concrete floor as he was laying his back. I placed my right foot under his head to prevent his head from making contact with the concrete as other officers were trying to restrain him. We were able to restrain Mr. Gilmore from "thrashing" around; however, he started twisting his body and kicking his feet. I then grabbed the hobble restraint to prevent him from kicking his feet as other officers were restraining his torso. While trying to prevent Mr. Gilmore from kicking his feet, Mr. Gilmore kicked his feet toward me where his feet contacted my right shin. This caused the back of my leg to strike the bench located on the wall. I was not injured but believed

if Mr. Gilmore was allowed to continue to move his feet I or other officers would become injured from his feet.

I placed my right leg in between Mr. Gilmore's thighs. His pants were pulled down exposing his genitals and buttocks. My right foot was in between his thighs pressing his pants to the ground which assisted with keeping Mr. Gilmore from kicking his feet as I was holding the hobble restraint. Mr. Gilmore was laying partially on his right side during this time and I was sitting on the bench holding resistance on the hobble restraint. The decision was made to place metal leg shackles and handcuffs on Mr. Gilmore. PSO Rodriguez placed the leg restraints on Mr. Gilmore's ankles and I fed the handcuff portion of the restraints up to Mr. Gilmore's wrists where PSO Terrell placed the handcuffs on Mr. Gilmore.

At one point, Mr. Gilmore laid over onto his stomach and I told the other officers to roll him back on to his side. We rolled Mr. Gilmore onto his right side and he appeared to be breathing normally. The South Scott Ambulance Service arrived. The paramedic gave Mr. Gilmore a sedative prior to Mr. Gilmore being placed onto the gurney. Mr. Gilmore was transported by South Scott Ambulance Service to Missouri Delta Medical Center. PSO Rodriguez rode with the ambulance to the hospital.

There were a total of five victims during this incident.

Mr. Gilmore bit my right hand but did not break the skin. PSO Rodriguez was kicked in the face and was almost bit by Mr. Gilmore. Mr. Gilmore spit at PSO Terrell's face which caused Mr. Gilmore's saliva to enter PSO Terrell's mouth. Mr. Gilmore grabbed PSO Hays' leg and squeezed causing pain to PSO Hays leg. PSO Dobbs was struck in the face when Mr. Gilmore kicked his feet toward PSO Dobbs.
